

Boyers Case Update: CHRIS

Overview: MidSOUTH Trainer Mary McCalla created 23 student cases and 1 trainer case with the Boyers case information to help with the inability to key the placement screen in CHRIS.

How this changes things: The Boyers case had to be moved to 04/06/2024 for the open/removal date. Therefore, the seventy-two-hour hold was taken on 04/06/2024, a Saturday.

Curriculum Note: The curriculum has not been updated to reflect the new dates. So, the participant manual pages 6-9, 15, and 31, the Affidavit handout, the Calendars, and all examples will have the old dates (2017).

The case had to be created after 08/01/2023 due to the pay scale increase in CHRIS.

Boyers Case Update: CHRIS

The removal screen or the first placement will not have already been completed.

Participants can either key her into a temporary placement on the 6th and then into a provisional placement on the 7th or simply key her into the provisional placement on the 6th.

2017 Case: If you prefer to use those, the old Boyers cases (2017) are still on their workload.

The only thing we can not do in this new Boyers case is show the Investigation link to the case. This is because when the Hotline staff started using ARFocus last summer (2023), they blocked making new referrals in CHRIS, so we cannot create new referrals in our current version of CHRIS.

Additional new dates:

Day 1 set CHRIS time to April 8, 2024- Monday after removal.

Day 2 set CHRIS time to April 15, 2024

Day 3 set CHRIS time to April 22, 2024

Day 4 set CHRIS time to April 29, 2024

Day 5 set CHRIS time to the current date until after July 12, 2024, then use July 12th.

PC Hearing: April 12, 2024

Adjudication Hearing: May 10, 2024

1st Review Hearing: August 9, 2024

Court report due by: July 26, 2024

Worries: All the Jefferson Co homes are overdue for re-evaluation, so that will need to be fixed at some point. We can still use the placements but must acknowledge that the re-evaluation is overdue.
